



## Southmoore Instrument Arts Program Early Release Form

The band directors understand that safety and security of our students simply cannot be compromised under any situation. We also understand that many band events are scheduled throughout the year and there are occasionally conflicts that occur with family functions or other school organizations that may be resolved through departure with family from limited band events. In order to create a safe means of early release of students this form has been created. Please read all regulations and sign below.

### **Procedure**

1. Student turns in this form at least 48 hours prior to the band event to Mr. Mewhorter.
2. Mr. Mewhorter will accept or decline the request and notify the parent and/or student.
3. If accepted, Mr. Mewhorter will distribute the form to Mrs. Cash our bus chaperone coordinator. The immediate family member must locate Mrs. Cash in order to sign the form at the band event in order to secure the release of the student.
4. **Please note, this form is not simply an "I do not want to ride the bus home" form. This form is created in an attempt to help families perhaps staying in town or departing somewhere other than home. Misuse of the form will eventually result in students being required to ride bus transportation to and from all events regardless of the circumstances.**

### **Guidelines**

1. This form must be signed and approved at least 48 hours prior to any event.
2. The early release may only be requested by a legal guardian of the student. The student will only be released to a legal guardian or immediate family member upon prior approval of a legal guardian. Mr. Mewhorter or the band representative may ask for legal identification before releasing the student.
3. The student will not be released until the designated immediate family member has signed this form at the band event. It is understood that Mrs. Cash may not always be easily available to locate prior to our release, especially at a contest, and therefore the immediate family member may have to meet Mrs. Cash at the bus prior to the band's departure to sign this form and secure the release of the student.
4. Students are not excused from a performance due to early release.
5. Approval or rejection of an early release from band activities is a decision upon by the Mr. Mewhorter.
6. Early release is only available at select events.
7. The legal guardian assumes all responsibility for supervision of this student immediately upon the release of the student from the band.
